1.1 Mayor Cullimore opened the meeting at 7:00 p.m. and welcomed those in attendance.

1.2 The Pledge of Allegiance was led by Mayor Cullimore.

3.0 **PUBLIC HEARING**

3.1 **Public Hearing to Receive Input on a Proposed Change to Chapter 19.90 “Amendments and Rezoning” of the Cottonwood Heights Municipal Code to Correct Information Regarding Requirements for Public Hearings as Required by the Utah State Code**

3.1.1 Planning Director Michael Black explained that when the Land Use Development and Management Act for cities was changed through the legislature, many of the requirements for holding public hearings for zone changes and general plans changed. The proposed ordinance brings the City’s Municipal Code into compliance with Utah State Code.

### **5.2 Salt Lake County Sheriff's Report**

- 5.2.1 Detective Dan Bartlett presented the June 2008 statistics. There were 1086 calls for service resulting in 564 cases. The calls that came in were similar to last month's numbers. June events that the Sheriff's office participated in included the St. Thomas Moore 5K run; AAA Safety Fair; and the Neighborhood Preparedness Fair.

Detective Bartlett reviewed several cases that occurred this month including that of a young man that sold cocaine in front of Detective Bartlett at McDonalds. The Doll House trial starts on Thursday and the Sheriff's office will keep the Council informed.

Night Out Against Crime will be held August 26<sup>th</sup>. Detective Ford has requested that anyone wanting to have a block party let him know by July 21<sup>st</sup>.
