2.0 **REPORTS/PRESENTATIONS**

2.1 **Presentation to Deputy District Attorney Sean Torriente**

4.0 **ACTION ITEMS**

4.1 **Consideration of Ordinance No. 36 Amending Title 19 to Include a New Section 19.82.121, "Transit Facility Advertising"**

- 4.1.1 Mayor Cullimore explained that the proposed Ordinance is the first step in removing bus bench advertising from Cottonwood Heights. Over the next two years bus benches will be replaced with shelters and benches that are primarily funded by the City, which the City believes it will improve the appearance of the City.

Community Development Director Kevin Smith noted that the bus bench companies and the advertisers on the benches have been involved in this process since its beginning and will be notified of the changes.

- 4.1.2 **MOTION:** Councilman Bracken moved to adopt Ordinance No. 36. The motion was seconded by Councilman Thomas and passed unanimously on a roll call vote.

4.3 **Consideration of Resolution No. 2006-03 Authorizing Entry into an Interlocal Agreement with the City of Holladay Pertaining to Distribution of Tax Increment in the Olympus Economic Development Project Area**

- 4.3.1 City Attorney Shane Topham explained that Holladay City created an Economic Development zone through its Redevelopment Agency that included Lot #1 of the Millrock Park Subdivision. At the time, Holladay City was unaware that one acre of Lot #1 was in Cottonwood Heights. He said that there is an issue on how the property tax distribution should be paid, and the Salt Lake County Assessors Office has asked the cities to enter into an Interlocal Agreement providing for how the property tax is split until such time as the City's boundaries are adjusted to move the boundary line. Mr. Topham said the Council agreed to start the process of moving the boundary, which will take a number of months. In the meantime there is property tax that needs to be distributed and the proposed Agreement will deal with the property tax issue until the boundary is adjusted.
- 4.3.2 **MOTION:** Councilman Jones moved to approve Resolution No. 2006-03. The motion was seconded by Councilman Anczak and passed unanimously on a roll call vote.
