General

The meeting was called to order at 6:30 p.m. by Gordon Nicholl.

Sheriff's Report

Deputy Scott Hansen gave the sheriff report. He reported on the recent crime figures. He urged citizens to keep their eyes open and report any suspicious circumstances to the sheriff.

Salt Lake County Fire Department

Gordon Nicholl introduced Steve Halligan from the Salt Lake County Fire Department. He will report to the Community Council each month on the activities on the Fire Department and take questions from the Council and citizens.

ACCT Report

Pat Warner reported on the last ACCT meeting. This had been a short meeting with nothing of importance being discussed. The next meeting will incorporate the prioritizing of the Capital Improvement project requests.

Salt Lake County Mayor's Office

Jim Braden representing the Salt Lake County Mayor's office mainly discussed the program for water conservation. He handed out flyers for the Salt Lake County spring clean up program and copies of a newspaper article regarding the incorporation/township proposal for Cottonwood Heights.

Incorporation

Kit Lindsey reviewed the status of the incorporation. The feasibility study is scheduled to be completed the latter part of May.

ZONING

There were no official zoning issues to come before the council this month.

Miscellaneous

Utah Crime Prevention Alliance

Butler Middle School Parking Lot

Mike Peterson reported on the plans to completely revamp the Butler Middle School parking lots and the impact on the community while this is under construction.

Nantucket Drive

Tom Beggs of Nantucket Drive reported on the problems that are being encountered on this street. He was supported by some of his neighbors. The areas of concern were:
A drug house, which has since been vacated;
2 story detached buildings being erected in people's yards, without notification from the zoning department;
houses with 6 or 7 vehicles in the driveway or on the street, many without registration and with engines missing etc.;
the speeding vehicles especially from Brighton High School.

Pat Warner offered to look into the zoning infractions;
Deputy Scott Hansen would follow up on the speeding problem;
The residents were advised to report the parked vehicle problem, as the County would not act on this without a formal complaint.

With no further information to come before the Council the meeting was adjourned at 7:30 p.m.
