Said to date from 1912 (tax card), the Colebrook House appears to have been a late Victorian Cottage or early Craftsman-influenced bungalow. The old tax card shows it to have a T-shaped floor plan with filled-in front and rear porches, making the overall floor plan rectangular in shape. Given that there were three mortgages taken out on the property from 1891 to 1900, first by the Brinton family and then by Charles and Sarah Colebrook, it could be that the house was built in two periods, one the interior rectangle to the right, which is about the size of a simple hall-parlor house typical in the area in the 19th Century, and later, in about 1912, the gable-fronting section on the left, also built when Charles and Sarah Colebrook owned it. In any event, its present appearance, being the same as shown in an old tax photo, dates from the period of Colebrook ownership, whether Charles or his son, Lewis.

The Colebrook House sits on a 0.19 lot carved out of a much larger property as described in the history below. It is a one-story, wood-frame, wood-sided dwelling. Its front porch has been filled in, belying its original crosswing or T-shaped floor plan. The exterior siding and trim may have been modified, perhaps when the porches were enclosed. The projecting front wing is gabled with the roof pitch changing on both sides as the rake of the pitch approaches the outside walls. The overall roof is hipped, while the rear/east addition has a low-pitched shed roof. The home's window openings are rectangular with fixed and sliding sashes. The very wide front picture window is atypical of this era but it appears this way in the old tax photo. The view of the front of the home is obscured behind the dense planting of trees and shrubs.

This house is 1,020 square in size and contains two bedrooms and one bath. It is said to have been remodeled in 1984. Also on the site, accessed by the south, concrete driveway, is a gabled, vertically wood-sided garage.

The Colebrook Residence sits on small lot which was originally part of a quarter section-sized property homesteaded and patented by early Butlerville settler Thomas Wilkerson. He was born in Richmond or Clay, Kentucky in 1797, the son of David and Elizabeth Wilkerson. In 1827 he married Elizabeth or Eliza Followell and they had eleven children. In 1852 the family, the numbering the parents and six children arrived in Utah, eventually becoming among the first settlers of Butlerville. In the 1970s the family moved to Kanab where Thomas died in 1882, followed by Elizabeth in 1883. In 1875 Wilkerson sold the land to well-known father and son L.D.S. church leaders and real estate investors, David (1814-1878) and David Branson Brinton (1850-1929). In 1877 they sold it to Joseph H. Brinton, David B. Brinton's brother (1852-1915), a blacksmith and resident of Holladay. In 1882, Joseph sold it to Caleb D. Brinton, another brother (1848-1936). In

both 1891 and 1892, Caleb and his wife, Emily M. Brinton, mortgaged the property, first to John Willoughby and then to Halver Seaversen, suggesting that a home may have been built and improved or expanded at this time.

In 1899 the Brintons sold the larger property to Thomas and Juliette Blackburn, who took out another mortgage on it in 1900. The next year they sold the property to Charles and Sarah Colebrook who, in the same year, also took out a mortgage. Again, it appears that a house was involved—perhaps an early part of this house or another one on another part of the lot.

Charles Colebrook was born in Utah in 1854, son of English immigrants and Mormon converts Charles and Virtue Ann Colebrook. In 1884 he married Sarah McGhie, born in Provo in 1866 to Scottish immigrants William McBlaine McGhie and Mary McBlaine McGhie, among the first settlers of Butlerville.. After their marriage, the Colebrooks built their first home on the southwest corner of what became known as Colebrook Corner, located at the intersection of 20th East and 70th South (now Highland Drive and Ft. Union Blvd.). Here their son Lewis and their grandchildren built their homes, creating a small family sub-neighborhood.

Charles was a railroad builder who helped construct four railroad lines in Utah, one in Wyoming and one in Montana. He served three years as a Jordan School District board member and for twelve years on the old 57th District School Board. He also worked as a constable and county road supervisor and as a founder and director of the Brown and Sanford Ditch Company. Charles was a farmer and active church man, functioning for six years as bishop of the L.D.S. Butler Ward. He was still working his farm and milking cows at age 80. He died in July of 1943 or '44. Sarah passed away on New Years Day, 1953.

Given that Charles and Sarah took out a mortgage on this property in 1900, it is possible that they had a home built here then, either for themselves or other family members. In 1907 they sold the property to their son, Lewis. He and his wife, Lucy, owned it until 1931.

Lewis Charles Colebrook was born in Butlerville in 1885. He married in 1904 and he and his wife, Lucy E. Colebrook, took out mortgages on the property in 1929 and '30 at the beginning of the Great Depression. Their purpose in mortgaging is not clear, nor is it certain that they ever lived in the present house, but they were the owners of the property in 1912 when the house supposed was built, so we call it the Lewis C. and Lucy E. Colebrook House. In 1930 they lived with their six children and two other children in a rented house on 28th East, not in the house they owned on 27th East. In 1940 they lived at 7233 S. 23rd E., in the Colebrook Corner area, and the next year they were at 7050 Highland Drive. Moreover, they are also associated with the house at 7447 S. 2300 E.

In 1931 the Colebrooks sold this property to Virginia Latses, wife of James Latses, who is a co-owner in 1937 when they took out a \$7,000 mortgage on the property. They owned it until 1945 when Virginia, now a widow, sold it to Sam F. Soter and John Loumis. James John Latses or Latsis was born in Greece in about 1895 and immigrated to the United States in 1906. His parents were John and Marigo Martsoukis Latses. His wife Virginia Karofotis Latses also was Greek and the 1940s directories show them living in Butlerville, probably in this home. James Latses died in 1944, causing Virginia to sell their dwelling.

The next owners, John and Lucie Loumis, kept the property only from 1945 to mid-1947 when they conveyed it to Sam F. Soter. John Loumis was born in 1916 to Constantine J. and Katherine Karafotis of Greece and he appears to have been the brother of Virginia Karofotis, one of the previous owners. A driver, farmer and manager by occupation, John and his wife, Lucie E. or B., are listed in 1949 as living at 7300 S. and 2700 E., which is close to the address of this property. John Loumis died in Bluffdale in 1991.

Samuel Frank Soter, the next owner from 1947 to 1951, was a realtor and worker for the Western Auto Supply Agency. Born in 1918, he was married to Eva Sargetis, born in Helper, Utah in 1924 to Greek parents Theros J. and Cleanthe M. Sargetis. Sam died in 1990. In 1951 his company, Soter's, Inc. sold the property to William and Francis Rideout, who owned it until 1962 when they conveyed it to one of their daughters, Helen R. Holmstrom and her husband, Harvey.

William Lovell Rideout was born in nearby Draper, Utah in 1879 to David Oliver and Mary Ann Rideout. A dry cleaning proprietor, his wife was Frances Roberta Rideout. After William died in 1963, Frances conveyed the house to one of their daughters, Helen Holmstrom, who owned it by 1965.

Other owners beyond the historic period include Neal H. and Mildred Haunm who owned it from 1972-76, Blain S. and Opal L. Gailey, owners from 1976 to 1980, Royal Terry, owner from 1980 to 1997, and the current owners, Eyra and Esteman Bor, who have had the property since 1997.



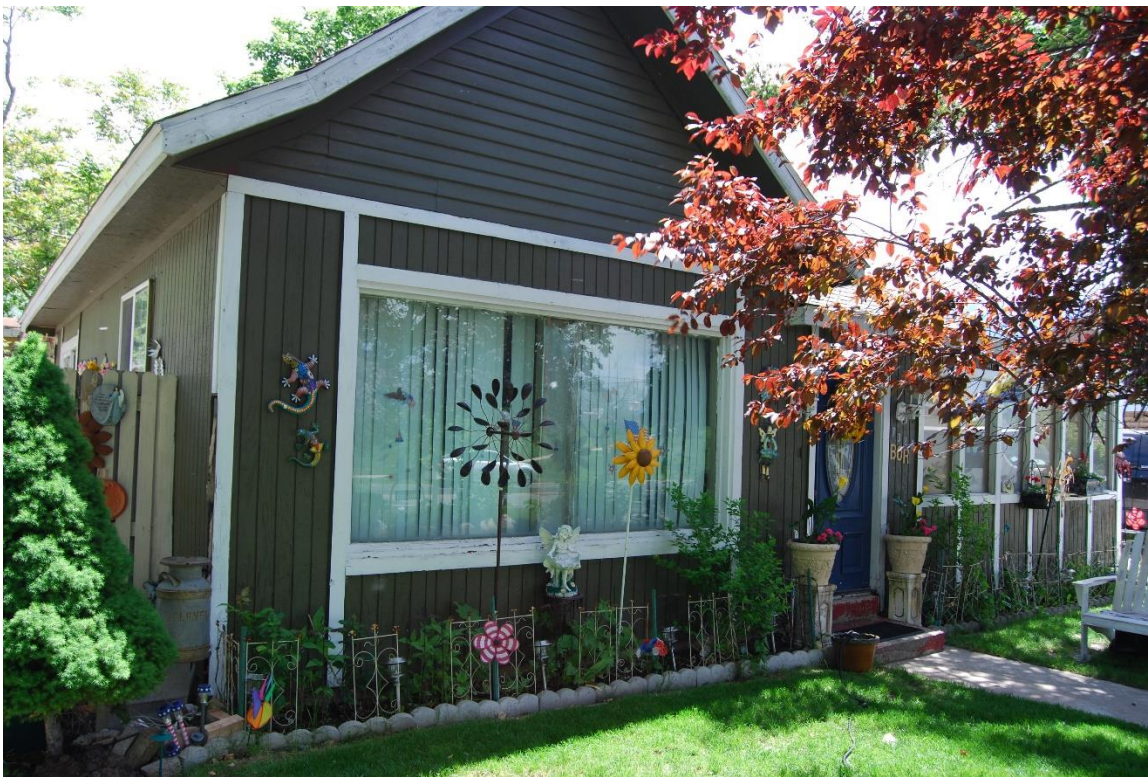

**THE TWENTY-ONE BISHOPS OF BUTLER
1ST WARD:1901-2001**

CHARLES COLEBROOK 3rd BISHOP OF BUTLER WARD: 1913-1919

Charles Colebrook was born in 1854. He lived a rich life during his 89 years. Reared on his stepfather's farm in Holladay, he saved the life of a neighbor boy who had fallen into the swift waters of Big Cottonwood Creek. Four years later, at the age of 22, he was employed as a logger surviving an accident when a rolling log pinned him to the ground.

Charles held a variety of positions during his life including that of railroader in the states of Utah, Montana, Wyoming and Washington, constable in the Butler Precinct, farmer, road supervisor, director of the Willow Ditch Company, officer of the Brown and Sanford Irrigation Company, a trustee of Butler School District No 57, and Board member of the Jordan School District (1905-1908).

While an officer of the Brown and Sanford Irrigation Co., he participated in two important decisions. First, constructing three Lake Blanch reservoirs at Mill B South in Big Cottonwood Canyon from late 1908 through the fall of 1910. Second, he negotiated and renegotiated with Salt Lake City officials beginning March 1923 to exchange the company's winter water for a culinary water system in Butlerville.

Charles was an active member of the Butler Ward serving in such positions as Sunday School Superintendent, 2nd counselor to Bishop Alva Butler, and for many years a member of the ward's Old Folks Committee. With the release of Bishop William W. Butler, he was sustained bishop of the Butler Ward serving until his release July 13, 1919.

As the ward bishop, he followed through with the Church program to conduct house-to-house visits to ward members and to have priesthood quorum officers make individual home visits to revitalized inactive members. Philander (1915) and Leander (1918) Butler, original settlers in Butlerville, died during his administration. At a June 14, 1914 meeting with the Relief Society he told the sisters that "They should always be prepared to respond when

NATHANIEL SOMMES JONES 5th BISHOP OF BUTLER WARD: 1931-1941

Nathaniel Jones served as bishop of the Butler Ward during the depression years that saw the establishment of the L.D.S. Church Welfare Program in 1936. Born in a one-room adobe house in Thatcher, Arizona he was named after his grandfather Nathaniel Vary Jones Sr., a member of the Mormon Battalion and first lieutenant of the militia of the Territory of Utah.

During his lifetime Nathaniel lived in three states - Arizona, Utah - Granite (1908-1917), Jensen of Utah County (1916), Slaterville of Weber County (1922-1923), Salt Lake City (1923-1930), Butlerville (1930-1976), and Idaho - near Gannett in Blaine County. Enlisting in the Army Air Corp during World War I, he served overseas in France, as a member of the U.S. Expeditionary Force against Germany.

Bishop Jones, a schoolteacher, taught in the Granite, Salt Lake and Jordan School Districts. Nineteen-year-old Florence Gertrude Smith became the love of thirty-two year old Nathaniel. The couple was married in the Salt Lake Temple 28, October 1925. Six children were born to them between 1926 and 1941 but each was a still birth. Subsequently, they adopted a daughter Marian, who later married Cottonwood Heights resident, LaVar J. Wilkinson.

Presiding over the ward during the depression years placed a heavy burden on Bishop Jones as he sought to work with members in need. Fortunately, members who were farmers raised commodities that could be canned or bottled thus enabling food to be on the table. Families, however, had limited means to pay off the loan Church headquarters had given the ward to build the 1930 chapel. Though Bishop Jones and his counselors expended considerable energy raising the needed funds to permit the chapel to be dedicated, their efforts fell short.

In 1936-37 Bishop Jones spearheaded the renovation of the amusement hall. The former schoolhouse's two chimneys were reduced to one. The work included installing a new roof, lowering the ceiling of the large amusement hall, and moving the stage from

the east to the west end to be closer to the classrooms. They also dismantled the 1893 school belfry and bell. Merlin Butler insured the bell was salvaged. The ward's membership that year was 321 with 14% attending sacrament meeting.

Events occurring during Bishop Jones' administration were the purchase in 1936 by East Jordan Stake of the Glacio Park recreational property at the mouth of Little Cottonwood Canyon, presiding at the funerals of former Bishop William Wootton Butler (9/16/36), Neri Butler (12/24/36) one of Butlerville's original settlers, and Ada Richardson (2/28/38) the wife of Bishop William C. Wootton. Ada was the 4th Relief Society President of the ward.

Following his release as bishop 7 December 1941 (Pearl Harbor Day), Nathaniel faithfully served as High Councilor in the East Jordan Stake from 3 May 1942 to 12 October 1952. His legacy was the work he did with Adult Aaronic Priesthood members. At his funeral May 5, 1976, a friend said, "Bishop Jones had a testimony of the gospel. He was kind and considerate of his fellow men. The gospel was foremost in his life and he built his life upon the Gospel." Bishop Clyde V. Buxton who conducted the services said, "Brother and Sister Jones lived their religion as well as any person including the prophets of the Church lived their lives. He was a credit to the land, a credit to his church, and a credit to his neighbors."

PHILLIP JENKINS BADGER 6th BISHOP OF BUTLER WARD: 1941-1942

Bishop Badger, age 26 years, was the youngest bishop of the ward's twenty-one bishops. Previously, he was a counselor to Bishop Jones. His counselors were Frank L. Cowley and Ormand Coulam. He served the fewest months as bishop, nine months, from 7 December 1941 to September 1942. A job in Idaho resulted in his short term of office. Phillip wasn't officially released, however, until 15 November 1942.

During his term in office Bishop Badger was successful in paying off the loan to the Church for the building of the 1930 Chapel that was torn down in 1990. In one night, he recalled, the obligation was

paid 11 June 1942 due to the pledges of ward priesthood leaders. A letter from the Presiding Bishopric's Office acknowledged the payment. This successful effort became Bishop Badger's legacy.

Bishop Badger came from an illustrious family. His father, Carl, was a prominent Salt Lake City attorney, candidate for Governor of the State of Utah, a Brigadier General in the Utah National Guard, and president of the Brown & Sanford Irrigation Company of Butlerville, Utah.

Grant Pedler, who was in his teens, remembered Bishop Badger as follows:

Although Phil Badger wasn't reared in Butlerville, he could lay claim to an early Butlerville connection. Phil's father, Carl Badger...owned one of the larger and better farms [fifteen-acres] in the community. The farm consisted of a large orchard located north of 70th South and East of 3100 East. The property is now owned by the [Reginald] Grane, [Frank] Christensen, and [Stan] Schoenfeld/[Pat] Tripp Schoenfeld families. It also consisted of a large tract of land on the south side of 70th South running south and west from about 30th East, including the main farmhouse with the cobblestone porch columns, which still stands across 30th East or kitty corner from the Kissell Chevron service station.

Carl Badger also built a rock house...perched on the brow of a hill that overlooked the Old Mill. The rock house was the second home built in Butlerville in the early 1930's. The house initially had four bedrooms which increased to six when a third story was completed. Phillip and his new bride, Margaret Naegle, spent their honeymoon at the rock house. The house, now owned by Sister Jeanne Bushnell, was the residence of the farm manager.

About 1939, Phil with his wife and two younger children, moved into the (30th East) main farmhouse to take over operation of the farm. Without meaning to stereotype farmers, I would have to say Phil didn't fit the mold. He was young, athletic, friendly and outgoing with great

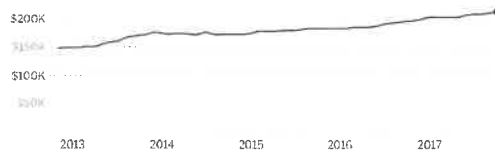
