Text Changes

- l) PL-95-4022 Side yard regulations

Side Yard regulations - None, except that wherever a building is located upon a lot adjacent to a residential zone or agricultural zone boundary, there shall be provided a side yard of not less than ten feet on the side of the building adjacent to the zone boundary line, and on corner lots the side yard which faces on a street shall be not less than twenty feet.

Front yard regulations - In C-1 and C-2 zones, the minimum depth of the front yard for all buildings, structures, walls or fences more than two feet in height shall be twenty feet.

Rear yard regulations - None, except that on corner lots which rear upon the side yard of another lot in a residential or agricultural zone, the minimum rear yard shall be ten feet.

- m) PL-95-4033 The maximum building height has been changed, and is now under section 10.04.095, therefore the diagram section needs to be corrected to by eliminating text that is no longer accurate.

The text is hereby amended by deleting the following
~~Maximum height. This illustration applies to zones F 1, R 1 43, S 1 G, R 1 6, R 1 10, R 2 10A, R 1 21, R 1 10C, R 1 0, R 2 0, R 2 6.5, R 2 10H, R 2 10C, R 4 0.5, A 1 C 1, C 1 L, C 2.~~

~~No building shall be erected to a height greater than two and one half stories or thirty five feet, and no dwelling structures shall be erected to a height less than one story.~~

- n) PL-95-4034 Disclosure when a natural hazards report is required.

Whenever a natural hazards report is required under this chapter, the owner of such parcel shall record a restrictive covenant running with the land in a form satisfactory to the county prior to the approval of any development or subdivision of such parcel, which includes the following:

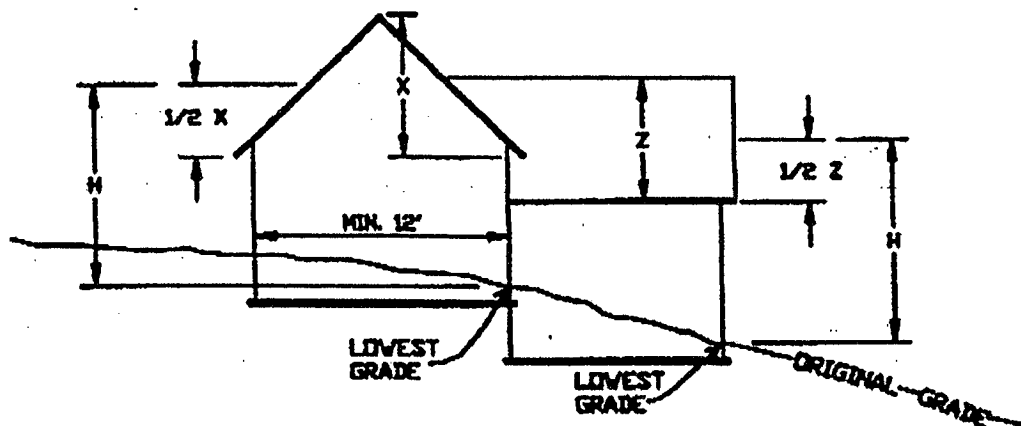
- a) A notice that the parcel is located within a natural hazards special study area as shown on the natural hazards map;
- b) Notice of existence and availability of the natural hazards report for public inspection in the county planning division natural hazards library.
- c) An agreement by the owner of the parcel and any successor in interest to comply with any conditions set by the planning commission or development services director to minimize potential adverse effects of the natural hazard(s).

- n) PL-95-4035 Dog training in commercial zones

Presently the zoning ordinance only allows training of dogs in the agricultural zones. This text change would make the service more convenient for the dog owners. **suggested addition** "dog training, provided all training is within a completely enclosed building.

- o) PL-95-4037 The maximum building height requirement in the zoning ordinance was changed about two years ago. This text change will add a new diagram showing the new building heights regulations.

A diagram entitled "Building height" for Title 19 of the Salt Lake County Code or Ordinances 1986 is hereby by added as follows:



Building height:

"H" equals the building height. "Z" and "X" are examples showing the vertical distance between the top ridge and the bottom of the cornice on a pitched roof. See section 19.04.095.
