The meeting was called to order at 6:50 p.m. by Joan Carman.

Upon motion made by Richard Guthrie, seconded by Bill Morris, and passed unanimously, it was

RESOLVED, to approve the minutes of the previous meeting, after correction.

Sheriff's Report

Kent Mackay reported on the crime statistics for the month of May.

Incorporation

Carl Durling reported on the status of the incorporation issue. Carl will start compiling the map for the area for the feasibility study. Presently this takes into consideration the community councils of Cottonwood Heights, Little Cottonwood Creek, South Cottonwood, Canyon Rim, East Millcreek and Mt. Olympus. Granite has declined to be included.

RESOLVED, to approve the minutes of the June 16th 1999 meeting on incorporation.

F.Y.I.

6608 Highland Drive. – Anna Eddington has purchased 2 acres of property at 6608 Highland Drive. This is wholly within a residential area but is close to the freeway. Anna would like to construct storage units on this property. She was at the meeting to get a feel for the council's reaction. She will then decide whether to submit formal application to the County. Her second choice would be medium density residential. A P.U.D.

Sanitation Dumpster – Mouth of Big Cottonwood Canyon

Steve Barth of Salt Lake County reported that the sanitation department wanted to construct a dumpster –trash compactor at the mouth of Big Cottonwood Canyon, on the South side of the road opposite the park and ride. This would serve the property owners in the Canyon who must dispose of their own garbage. It would only be available to these people – who would access it with a "swipe card".

After discussion and upon motion made by Richard Guthrie, seconded by Bill Morris, and passed unanimously, it was

RESOLVED, to thank Mr. Barth for bringing this to our attention.

#11723 7938 Danish Road – Subdivision

This was to be heard by the Community Council as the developer is asking for a variance. The County is requiring a 66' wide road. The developer proposes a 34' road including an 8' sidewalk.

Upon motion made by Richard Guthrie, seconded by Steve Hill and passed unanimously, it was

RESOLVED, to deny this request for an exception.

Upon motion made by Richard Guthrie, seconded by Carl Durling, and passed unanimously, it was

RESOLVED, to write a letter to Salt Lake County Commission asking that Salt Lake County's 13' easement on the East Side of Danish Road, directly across from the proposed subdivision, be utilized to widen the road, to save lives and injuries.
