

MINUTES OF A MEETING OF THE COTTONWOOD HEIGHTS COMMUNITY
COUNCIL HELD MAY 3, 1995 IN BUTLER MIDDLE SCHOOL.

General

The meeting was called to order at 6:30 p.m. by Karen Eyre.
The invocation and pledge allegiance were led by Troop 417.

Minutes

Upon motion made by Cameron Hansen, seconded by Jeannine Cunningham, and passed unanimously it was

RESOLVED, to approve the minutes from the previous meeting.

Commissioner Brent Overson

Commissioner Brent Overson, Chairman, Salt Lake County Commissioners, took a few minutes to present Richard Guthrie, Director of Salt Lake County Service Area #2 - Cottonwood Heights Recreation Center and member of Cottonwood Heights Community Council with a check for \$150,000. This is the first of four installments to be paid by Salt Lake County to the Service Area as a contribution towards the expansion of the Recreation Center.

Mr. Guthrie took a few minutes to thank Commissioner Overson and explain to the citizens present the role Salt Lake County plays in our community.

Boyer Development

Responding to an article in the Salt Lake Tribune that day Commissioner Overson invited comment from those present. The article referred to the Salt Lake County Commissioners' decision to allow Boyer Company to continue with the development of the property at the mouth of Big Cottonwood Canyon.

Mobile Neighborhood Watch

Captain Bill Morris of Salt Lake County Sheriff's Office presented a proposal for a Mobile Neighborhood Crime Watch. Training sessions will be held May 13 1 p.m. - 5 p.m. and May 20 9:00 a.m. - 5:00 p.m. Citizens are encouraged to sign up to attend the training sessions and get involved in this program.

U.A.C.C.

Brian Smith reported on the U.A.C.C. meeting.

Two main topics of discussion.

1. The proposals for Salt Lake County Recreation consideration were prioritized as

follows.

1. Taylorsville/Bennion converting a D.O.T. dumping ground to a 20 acre park.
2. Golden Hills trailhead.
3. East Millcreek Recreation Center expansion.
4. Canyon Cove park.
5. Purchasing of land adjacent to Wheeler Farm.

Union Park will get their two acre park funded through impact fees.

2. Incorporation.

There have been two meetings referencing incorporation in the last month. The members of Cottonwood Heights met at the Government Center with Sheriff Kennard and then met with four Councils at Hillcrest High School.

Don Machin was appointed of the Cottonwood Heights Ad Hoc committee.

The next step appears to be to conduct a feasibility study. Salt Lake County should conduct this.

The next meeting of the Community Councils - Union, South Cottonwood, Cottonwood Heights, etc. will be May 17, 1995 at 7 p.m. in Hillcrest High School

Nick Morgan, on behalf of the Council, commended Don Machin on his efforts and involvement in the community.

Trailhead to Foothills at Golden Hills

Commissioner Overson will be present at the June Cottonwood Heights Community Council meeting to discuss the issue of access to the Foothills above Golden Hills. The last three years the Council has submitted this project as the Capital Improvement request to U.A.C.C./ Salt Lake County. There is a lot of confusion regarding the extent of this project. Golden Hills Neighborhood Association would like a park as part of this project. Top of the World/Prospector Neighborhood Association has mixed feelings. Both associations will issue information flyers to their residents inviting them to attend the meeting on June 7 or write to Commissioner Overson with their views.

Zoning

Jeannine Cunningham gave the following report on zoning issues.

Target Sign - will be 22'8" high, 10' wide with interior lighting only. Tan/brown color.

Hillrise Apartments - this project is subject to revocation of the license because of failure to comply with Salt Lake County requirements. The hearing is scheduled for May 16, 1995 at 8:30 a.m. in Room N3701 of the Government Center.

Semaphore - A letter was sent to Salt Lake County Engineers requesting review of the placement of a semaphore at 1435 East Fort Union Boulevard. Ann Bower reported that this study is underway.
