A petition was available for citizens to sign opposing the widening of 3000 East from the Corporate Center to 7000 South and requesting sidewalks, park strips, etc.

PL-96-2335 6961 South 3000 East Twin Homes

Upon motion made by Tom Heath, seconded by Greg Alex, and approved unanimously, it was RESOLVED, to approve this application.

PL-96-2348 7530 South 2700 East PCS Wireless Communication Tower

Upon motion made by Tom Heath, seconded by Joan Carman, and approved with one abstention, it was

RESOLVED, to postpone a decision on this application until such time as the County Ordinance is made available and reviewed.

PL-86-2164-001 7056 South 2155 East Mother's Helper Day Care

The Council was informed prior to the meeting that the application had been withdrawn.

Karate Studio at this address is being operated illegally. Cottonwood Heights Community Council had denied this application but Salt Lake County Planning approved it. The neighbors reported that there are concrete trucks accessing the lane and parking, neighbors lawns are being driven over, and trucks are being parked at the building.

Upon motion made by Rand Call, seconded by Tom Heath, and passed with one abstention (due to lack of knowledge of the location, etc,) it was

RESOLVED, to write a follow up letter to Salt Lake County Planning Enforcement Division with copies to the Planning Commission asking for a response to our letter of last month and the possibility of a rehearing of this application by the Planning Commission.

PL-96-0511 Zoning Ordinance Amendment - Re-Township Zoning.

Upon motion made by Tom Heath, seconded by Joan Carman, and passed with one abstention

it was

RESOLVED, to approve this amendment with the stipulation that Salt Lake County Planning Commission exercise no jurisdiction over the applications filed previous to the canvass of the township and that they be heard immediately by the new Board.

Bill Pepperoni presented a proposal for a hotel on a 2.2 acre site at approximately 6600 South 1300 East to get some feedback from the community prior to taking any further action.

The Council did not like the proposal because they felt

- a) the property is not big enough for a hotel
- b) patrons would access it through the community
- c) no easy access to the freeway
- d) there would be neon signs to publicize it
- e) it would not be compatible with the neighborhood - height wise
