1.0 **WELCOME/ACKNOWLEDGEMENTS**

1.1 Mayor Cullimore opened the meeting at 8:00 p.m. and welcomed those in attendance.

2.0 **CITIZEN COMMENTS**

2.1 Ron Fullmer applauded the Council's efforts in forming a city police department and
believes it will make a tremendous difference to the City.

2.2 Tiffany Reiman said that near Meadow Drive there is an area at approximately 6600
South Greenfield Drive where there is access to the canal that poses a danger to
children. Ms. Reiman circulated pictures of the area.

3.0 **REPORTS/PRESENTATION**

3.1 **Unified Fire Authority Report**

3.1.1 Assistant Chief Mike Watson reviewed the statistics for the month of July 2008.
There were 78 fire calls compared to 119 in 2007; and 157 medical calls compared to
169 in 2007.

Chief Watson said that wildland and urban interface activities have increased across
the state. School is now back in session and motorists need to watch for the increased
pedestrian traffic. He also explained the Corner Canyon fire in Draper and how
difficult it was to get a handle on because of the steep topography and the winds.
There is a concern about mudslides in the area due to the loss of ground cover.

The customer service message for Stations 110 and 116 were reviewed.
