Sheriff s Report

Kent Mackay reported on the year's crime figures for Cottonwood Heights and compared them to one year ago.

Incorporation

Things are moving ahead with the petition to request a feasibility study. The community was encouraged to complete the petitions so that they can be turned in to the County for the study.

ACCT report

Joyce Smith reported on the ACCT meeting. The COG has reviewed the feasibility study recently completed.

General Plan Amendment

7076 Highland Drive – the present owners are requesting a general plan amendment changing the zoning from RM to C-1. The prospective purchasers wish to operate a beauty salon and day spa out of the building.

RESOLVED, to approve the general plan amendment change of zoning to C-1 to preserve the ambiance of the home.

Other Business

Park and Fire Station

Richard Guthrie reported that the park at Wasatch Boulevard had been funded for
\$350,000 for the year 2000. This will get them started with irrigation, grass and grading.
The fire station is also funded for some part in 2000.

Stor N Lock Storage Units

Cathy Trane reported on some problems with the storage units on Whitmore Way.
A sewage dump has been installed and is being used. There is no security on this. One
user failed to secure the exhaust and leaked raw sewage on Whitmore Way.
There is a lighted sign on at all times of day and night.
The security gate to the storage units has never been locked.
They are now offering to winterize and wash vehicles for the renters.
All these things were expressly excluded in the conditions agreed upon when the
applicant came before the Community Council.

Upon motion made by Carl Durling, seconded by Richard Guthrie, and passed
unanimously, it was
 RESOLVED, to write a letter to the a) County Health Department b) Salt Lake
County Commissioners c) Development Services asking that they research these
complaints and reexamine the application.

7000 South

completion.
