1.0 **WELCOME**

1.1 Mayor Cullimore opened the meeting at 7:00 p.m. and welcomed those in attendance.

1.2 The Pledge of Allegiance was led by Councilman Thomas.

2.0 **REPORTS/PRESENTATION**

2.1 **Administration of the Oath of Office to the Board of Trustees of the Cottonwood Heights Recreation Center**

2.1.1 City Recorder Linda Dunlavy administered the oath of office to the new members of the Board of Trustees of the Cottonwood Heights Recreation Center, Janet Janke and Carl Evans.

2.1.2 Mayor Cullimore presented certificates of election to the new members.

2.2 **Sheriff's Report**

2.2.1 Lt. Robby Russo introduced Art Brown, explaining that what brought him into the circle of law enforcement was a tragic situation in 1999 when he lost a grandson in an accident with a drunk driver. He dedicated his life to helping law enforcement in the pursuit of underage drinkers and driving under the influence of alcohol. Lt. Russo said that the legislation that has enhanced the enforcement of drunk driving would not have happened without him. He said that Mr. Brown and others have been responsible for obtaining grant money for portable breathalyzers and dash-cams.

2.2.2 Mayor Cullimore presented an award of appreciation to Mr. Brown for his service to the law enforcement community.

2.2.3 To honor Mr. Brown's work with law enforcement, Officer Heath Lowry was presented with the first annual Art Brown Award, for targeting the most DUI drivers and underage drinkers and exhibits determination in making the streets safe for the residents.

2.2.4 Detective Ford: presented statistics for the month of November. There were 934 calls for service which resulted in 631 cases. He is currently working on a comparison of cases and calls with other cities and will present those comparisons at the January 24th meeting.

Detective Ford updated the Council on the nursing home bandit, juvenile parties in the City, and the rape that occurred at the Phillips 66 service station off of Fort Union Blvd.
