Salt Lake County Sheriff's Department

RESOLVED, to approve this application.

PL-95-2331 3380 East 7000 South - 7 duplexes

After discussion with the neighbors of this property and upon motion made by Nick Morgan, seconded by Jeannine Cunningham and passed with one no vote it was

RESOLVED, to ask the County Planning Commission to rezone the subject property R1-10.

Community Council input to the County Commissioners

Each Community Council has been asked to review 1995 and express their requests for the County Commissioners in 1996.

Cottonwood Heights Community Council would like to:

- review the Master Plan for Cottonwood Heights;
- increase voter anticipation - a centennial goal;
- continue the Wetlands project;
- review the traffic problems
  - 6600 South
  - funding of the project to widen Highland Drive
  - funding of the project to widen Wasatch Boulevard
- include bike/pedestrian trails
- continue no commercial development between the canyons on Wasatch Boulevard
- continue no commercial development between 2700 East and Mouth of the Canyon on 7000 South
- retain pedestrian access to the canyons East of Wasatch Boulevard between Little and Big Cottonwood Canyons

#### Fax Machine

Upon motion made by Nick Morgan, seconded by Jeannine Cunningham, and passed unanimously, it was

RESOLVED, to approve the purchase of a switch box for the recently purchased fax machine for the chairperson of the Council so that the installation of another telephone line can be avoided.

#### Miscellaneous

Richard Guthrie reported on the recent Salt Lake County Budget.

\$90,000 will be expended on the Old Mill Pond park using money from impact fees on the area homes. This money will be used to create a nature park and a trailhead.

\$250,000 will be expended on Mill Hollow along with \$50,000 from the Salt Lake County Service Area #2 - Cottonwood Heights Recreation Center budget to be spent on grass, sprinkling system, a children's playground and if there is surplus 2 unlighted tennis courts and a pavilion. Treated soil from Decker Lake will be used for topsoil.

Upon motion made by Nick Morgan, seconded by Jeannine Cunningham and passed unanimously, it was

RESOLVED to adjourn.
