The meetings where there is public input are held on the third Thursday of each month at 7 p.m. in the Holladay Library.

Incorporation Report

Don Machin had attended a meeting on June 21 at the State Capitol and reported on the items discussed.

There will be a series of meetings on July 11, 18, 25 at 3 p.m. in Room 305 of the State Capitol under the auspices of State and Local Affairs Committee. Interested parties are invited to attend.

U.A.C.C. report - Brian Smith reported that the main item to come out of the meeting was to promote the National Neighborhood Act Coalition and participate in the August 1 block parties.

Solid Waste Management Act - This committee would like to send a representative to a council meeting to address this issue. Margaret to write a letter inviting them to attend the August meeting. This would be placed on the agenda prior to zoning.

Spare the Air Seasons - Flyers were available for handout at the meeting. This encourages citizens to car pool, restrict driving, etc.

Utah State Tax Commission - a representative would like to attend a council meeting to explain the revaluation process. They will be invited to attend the September meeting.
