We have grown accustomed to the predictability, reliability and comfort that has been afforded to us as motorists by our current transportation system. However, this system has proven incapable of accomplishing what I see as the only acceptable level of safety: "Zero Fatalities." In fact, by some metrics, both serious injuries and death continue to rise on Utah roadways.

As a city, we must consider that bicycling, walking and rolling on our roadways are allowed activities when done legally. As such, anyone choosing to participate in our roads legally should be afforded the same consideration for safety and convenience currently afforded to the automobile.

When municipal decisions overly focus on car traffic and convenience, government can lose sight of a top priority: community safety.

Shaping Our Future: Hillside Bond Moves Forward & Cottonwood Heights Turns 20!

The General Obligation Bond on the November 5th ballot passed by a 5%/800 vote margin. So what now?

City staff published a Request for Proposal (RFP) in the beginning of December asking for proposals from the development community to partner with the City on our town square project. The Staff and I have met with many of these companies over the last few weeks to discuss in further detail what the city hopes to accomplish with this project and have been encouraged with the feedback we've gotten. We expect to see submissions from many of them.

The RFP will officially close the first week of February and then the evaluation process to choose a partner will begin. We expect to have a development agreement signed a few months after choosing a partner and then "The Heights" project will officially be under way. Stay tuned to the

On January 14th, 2025, the City of Cottonwood Heights will celebrate our 20th birthday as a City. On January 15th, I will give a State of the City address, and dedicate a part of the speech to honor many of the City's founders. We will recognize our 2 previous Mayors, previous city council and planning commission members, along with those who have volunteered on official city committees. Previous staff and community partners will all be invited to help us kick off a fun, year long celebration.

Twenty years may seem like a blink of an eye in the grand scheme of time, but for Cottonwood Heights, it has been a journey filled with growth, community spirit, and amazing accomplishments.

As I reflect on the beautiful place we call home, Cottonwood Heights is not just defined by our stunning mountain views, our well-kept parks, and our family-friendly neighborhoods—though those

Transportation Safety may seem like an odd subject for starting off the New Year, but I chose to put aside other topics after contemplating the latest fatality that occurred on State Route 190/Wasatch Blvd in December.

In our culture, we refer to these events as "traffic accidents". But safety is no accident. Many of these events are preventable through intentional design, monitoring and regulation.

According to the US Department of Transportation's Safe Systems Approach ("Approach"), adopted as part of the Bipartisan Infrastructure Bill, cities were granted the great responsibility to direct federal funds towards studying, planning and implementing necessary preventive countermeasures such as engaging robustly with residents to understand where they perceive dangerous conditions, then deploy necessary measures to proactively prevent the next transportation-related death or serious injury.

The Approach requires a municipality to promote the goals contained in a "safety action plan" in order to qualify for funding. In 2023, the Metropolitan Planning Organization (MPO), Wasatch Front Regional Council (WFRC), created a template that can be used by all WFRC cities called a Comprehensive Safety Action Plan (CSAP). Cottonwood Heights has been one of the first medium-sized cities along the Wasatch Front to utilize that CSAP to apply for grant funding.

attributes are noteworthy. What truly defines us is the sense of community that we have fostered over these two decades. It is in our shared experiences, our neighborly smiles, and our commitment to supporting one another.

Your participation, your engagement, and your voices have shaped our community in profound ways, guiding our development and enriching our culture.

I encourage each of you to continue to engage with your neighbors, to participate in local activities, and to bring forth new ideas that will help us shape the identity of Cottonwood Heights as we move forward. Come celebrate with us this year as we honor our community and celebrate 20 years together as the City of Cottonwood Heights. ■

The Approach also indicates that to eliminate all fatal outcomes, all of us must accept the reality of human error.

Prioritizing slower speeds in places where there are known pedestrians or cyclists is important because when a pedestrian is hit by a vehicle travelling at 20 mph the survival rate is nine out of ten. At 40 mph, the rate of survival is less than two out of ten.

The following are excerpts from the US Department of Transportation's "Safe Systems Approach":

1. **Death and serious injuries are unacceptable.**
2. **Humans make mistakes.** People will inevitably make mistakes and decisions that can lead or contribute to crashes, but the transportation system can be designed and operated to mitigate the outcomes of human mistakes and avoid death and serious injuries when a crash occurs
3. **Humans are vulnerable.** Human bodies have physical limits for tolerating crash forces before death or serious injury occurs; therefore, it is critical to design and operate a transportation system that is human-centric and recognizes physical human vulnerabilities.
4. **Responsibility is shared.** All stakeholders are vital.

5. **Safety is proactive** rather than waiting for crashes to occur and reacting afterwards.
6. **Redundancy is crucial.** Reducing risks requires that all parts of the transportation system be strengthened so if one part fails, the other parts still protect people.

# Problems associated with electric scooters and bicycles

CHPD is grappling with numerous challenges associated with the rise of electric scooters and bikes. A key issue is the lack of comprehensive regulations, which complicates the enforcement of safety standards and traffic laws. The increasing prevalence and hazards of these vehicles have led to accidents resulting in severe injuries and numerous complaints about young riders competing with vehicles on the roads, posing dangers on sidewalks, and becoming



liabilities on private property.

While some municipalities have begun

implementing ordinances to improve safety and the user experience, a broader approach by the Utah Legislature may be necessary. These vehicles often reach speeds similar to motor vehicles but lack the same oversight or licensing requirements, creating ambiguity in enforcement. The ability of riders to move between roads and sidewalks further complicates jurisdictional authority, raising potential conflicts between vehicular and pedestrian safety.

Despite their increasing popularity, these devices currently face minimal regulation. For instance, motorcyclists must meet age requirements and obtain proper licensing, including a helmet mandate for those under 18. Identifying offenders poses another challenge, as these riders often lack registration and identifiable license plates, making accountability difficult.

As popularity grows, ensuring these devices do not disrupt or pose risks to the



community presents a complex task for law enforcement. The police department has proposed discussion points for the Council, addressing issues like designated travel areas, insurance, age restrictions, speed limits, and passenger guidelines. As we work through these considerations, which also include off-road use on city trails and open spaces, we will keep the community updated on our progress. ■

We also want to inform residents that the city plans to issue bonds starting in early 2025, further paving the way for the exciting developments ahead.

We appreciate your ongoing support and engagement as we work to create a town center that enhances community life and fosters connections among residents. Stay tuned for more updates as we progress on this important project.



Put your undecorated trees on the curb, and WFWRD workers will collect them the day after your regular collection day. If they don't pick up your tree that day, they will

return the following week.

Remember to:

- **Remove all snow, decorations, lights, or flocking from the tree**
- **Cut trees taller than eight feet into smaller sections**
- **Put your tree stand away (WFWRD can't accept trees in tree stands)**

Do not put trees in your garbage, recycling, or green waste cans. **As a reminder, Wasatch Front Waste cannot accept artificial trees.** ■


# Celebrating 20 Years of Cottonwood Heights: 2005-2025

Cottonwood Heights marks two decades as a city, celebrating the vision and efforts that led to its incorporation on January 14, 2005. After years of advocacy, residents achieved their goal of establishing a municipality, providing local control over critical decisions. Kelvyn Cullimore Jr. was sworn in as the city's first mayor, bringing his leadership and dedication to the fledgling community.

Under Mayor Cullimore's tenure, Cottonwood Heights rapidly built the foundation for its success. The city launched essential initiatives, such as creating its municipal code, forming the Cottonwood Heights Police Department in 2008, and hosting events like Butlerville Days to foster community spirit. The incorporation also enabled the city to form key partnerships, including its instrumental role in establishing the Canyons School District in 2009.



The decision to incorporate brought a sense of identity and pride to residents, allowing them to take control of their community's future. Twenty years later, Cottonwood Heights continues to thrive, celebrating its growth and achievements while looking ahead to a promising future. ■

## SUSTAINABILITY

### Sustainable Heating

As the world increasingly focuses on going green, sustainable home heating has become a key priority for homeowners. Traditional heating systems, such as oil or gas furnaces, collectively contribute significantly to greenhouse gas emissions in the Salt Lake Valley. Transitioning to sustainable alternatives not only benefits the planet but can also lower energy costs and improve indoor comfort.

One popular solution is the use of **heat pumps** (shown in the photo below), which efficiently transfer heat from the air, ground, or water into your home. Powered by electricity, heat pumps are highly energy-efficient, especially when paired with renewable energy sources like solar panels. Modern heat pumps can provide both heating and cooling, making them versatile and cost-effective year-round.

**Biomass heating** is another green option, using organic materials like wood pellets or agricultural waste as fuel. These systems emit significantly less carbon than fossil fuels, especially when sourced locally. However, it’s important to ensure sustainable sourcing to avoid deforestation or resource depletion.

In Utah, where we have abundant sunlight, **solar thermal systems** are a compelling choice. These

systems use solar collectors to heat water, which is then circulated to warm the home. While the initial installation can be costly, solar heating is virtually emission-free and offers long-term savings.

**Improving insulation** and sealing air leaks can further reduce energy consumption, regardless of the heating system used. Combining these strategies creates a sustainable and efficient home that minimizes environmental impact while maximizing comfort.

Investing in sustainable heating not only helps the planet but also adds long-term value to your home—a win-win for everyone. ■
