Because the County Commission denied a text change to allow
reconstruction of non-conforming building, the new Board of
Adjustment chapter needs to also reflect that fact. This text
change will take the work reconstruction out of the special
exceptions section of the Board of Adjustment chapter.

h. PL-94-4003 - February 22, 1994 9:00 a.m.

The proposal is to take the time limit out of the administrative determinations. In most cases the time required to make a determination is about three weeks but in some cases two months may not be enough time.

i. PL-94-4004 - Mar 22, 1994 9:00 a.m.

When the County adopted the highway standards this section should have been updated to refer to title 14. This text change would do that and also expand the ordinance to cover uses, which also includes structures. For example storage yards and junk yards without buildings would now need to install curb gutter and sidewalk.

j. PL-94-4005 - Mar 22, 1994 9:00 a.m.

This ordinance is an attempt to prevent unsightly and dangerous fencing in the FR zones which cover the canyon areas. Fencing is defined and a section is added to the FR zones to require an approval through Development Services.
