**SHERIFF'S REPORT**

Bill Morris introduced Kent Mackay, the officer assigned to this area.

Bill Morris went over the latest statistics for the area and entertained questions and comments from the audience.

**ACCT REPORT**

Joyce Smith and Carl Durling were not present to give this report.

**TIMELINE**

Concern was expressed over the length of the meetings and it was suggested that a timeline be implemented. This will be addressed further in January when the new chairperson is in place.

**TRAFFIC CONTROL ON WHITMORE WAY**

Cathy Trane expressed concern about the lack of enforcement of no parking signs on Whitmore Way. These signs were installed as a result of a meeting with Mr. Horiuchi and are to stop people parking on either side of Whitmore Way around the vicinity of the LDS church.

Upon motion made by Greg Alex, seconded by Bob Good, and passed unanimously, it was

RESOLVED, to write the stake president asking that he pass tell his church members that tickets will be written on illegally parked cars with a copy to the Sheriff's office.

## **ZONING**

Upon motion made by Bob good, seconded by Joan Carman, and passed with one no vote it was

RESOLVED, to deny this application based upon the facts that the applicant did not show, that it is on a busy street, it is not zoned for this and the council is generally against home occupations with people coming to the house.

#12944      8295 S Wasatch Boulevard – Fire Station Salt Lake County

After much discussion with the contractor and the architect and upon motion made by Bob Good, seconded by Joan Carman with one member abstaining, it was

RESOLVED, to defer a decision on this application for one month and invite a member of the Fire Department to come to the December meeting to answer some neighborhood concerns.

## **OTHER BUSINESS**

The power line proposition failed in the election. Karen Eyre was going to ask that the precincts in the most affected area be canvassed. If it shows that theses precincts voted in favor of the Service Area the Commissioners will be asked if this could be pursued with only these precincts.

Upon motion made by Richard Guthrie, seconded by Greg Alex, and passed unanimously, it was

RESOLVED, to form an Ad Hoc committee with Karen Eyre as the chair to pursue this issue. Karen may call upon members of the community to serve on the committee.

The meeting was adjourned at 8:00 p.m.
