

**MINUTES OF A COTTONWOOD HEIGHTS COMMUNITY COUNCIL HELD
DECEMBER 7, 1994 IN BUTLER MIDDLE SCHOOL.**

PRESENT: Gordon Thomas, Karen Eyre, Cameron Hansen, Verl Buxton, Nick Morgan, Richard Guthrie, Jay Brown, Brian Smith. Absent - Ken Verdoia.

The meeting was called to order at 6:30 p.m. by Gordon Thomas.

Jay Brown gave the invocation.

Karen Eyre led the Pledge of Allegiance.

Tonight is the final meeting for Gordon Thomas, Verl Buxton and Jay Brown as Council members

Brian Smith was welcomed as a member of the Council replacing Kendra Thuet.

Zoning.

PL-94-2276 - 7025 South Park Center Drive

Paul Crabtree representing Target Stores addressed the zoning for the 185,000 sq. ft. store to be constructed at 7025 South Park Center Drive. One concern addressed by the Council was the traffic. This will be monitored and lights installed when deemed necessary.

Upon motion made by Verl Buxton, seconded by Cameron Hansen, and passed with one no vote, it was

RESOLVED, to approve this application wiith the recommendation that they be requested to reduce the size of the sign to be erected on Fort Union.

Salt Lake County Traffic Engineer - Ann Bowers

At the request of the residents of the Community Ann Bowers was present at the meeting to review the traffic plans for the Cottonwood Heights area.

Highland Drive South from Bengal Boulevard to Sandy City limits will be widened to 4 lanes + a turn lane, with the potential to go to 7 lanes.

Bengal Boulevard from 2300 East to 7000 South will have a sidewalk installed.

Bengal Boulevard between the High School and the intersection of Highland Drive will be the responsibility of the apartment complex owner to improve.

Creek Road - 1300 East to Highland Drive will have a bike/walking trail, berm, sidewalk, and be increased to four lanes with a turn lane.

Fort Union boulevard, 1700 East to Highland Drive will be widened to 4 lanes with a turn lane.

7200 South, 1400 East to 2000 East will have sidewalk installed.

The question was raised about the possibility of installing a pedestrian walkway through Newport Way to Bengal Boulevard for the school children to use and the returning of the balance of the property to Cannon Mortuary. Ann Bowers will look into this.

Is there any solution to speeding traffic through neighborhoods - specifically the high school traffic on Newport Way, etc.?

Ann Bowers said that one method which had been tried successfully in Seattle is landscaped traffic islands in the center of intersections forcing traffic to slow down to go through them. It has been tried unsuccessfully once in Salt Lake County but it was a very temporary poorly designed attempt. Ann will be in contact with Seattle to get more information on this.

Cameron Hansen reported on the November U.A.C.C. meeting.

Highlights included:

- call END-GRAF to report Graffiti;

- 5 people will be appointed to the trails committee;

- "The Cottonwoods" will be allowed to vote on the incorporation issue prior to

January 7, 1995;

- problems with some of the property being constructed in Mill Hollow;

- \$42,650 recieved in impact fees in the Council area for the past couple of years. This will be spent in this area.
